**Regulations: Monroe County Health Permit required prior to event and placed in plain view of your food trailer.**

All food vendors must follow all festival rules. No alcohol or drugs are allowed on the premises. Set up may be done after 9am on Thursday, May 15. If set up needs to be done on Wednesday, May 14, please contact a committee ahead of time. There will be no security Wednesday and Thursday nights but it will be furnished Friday and Saturday night.

Break down cannot be done until the end of the festival, which is around 10pm on May 17. Any vendor pulling out early will forfeit your return to any future events.

A copy of your liability insurance must accompany this application or be submitted prior to set up. Payee is to be: Harrodsburg Heritage Festival.

Please apply for your health permit at the Monroe County Health Department. The Health Department will be on site to do inspections on Friday, May 16. Any vendor not having the proper permit will not be allowed to open for business.

Please mail completed and signed application along with full payment by April 1, 2024 to the address below. Payments are to be made to Harrodsburg Heritage Days. Full payment must be made before your unit is allowed to set up for our festival. If extended time is needed for payment, please contact Pam at: #812-320-2864. A no-show for our event will forfeit a refund of your vendor fee.

If you are a prior food vendor and cannot make it to the 2025 festival, please notify us ASAP when you receive this application so we can fill your spot. If you are a new food vendor, submitting an application does not guarantee you a spot, but we will review it and notify you if we have an opening.
